# INSTRUCTIONS FOR ASSEMBLY/DISASSEMBLY

## 1. Access to the Expo Area during Assembly

During the 16<sup>th</sup> of April, the Area will be open only until 20:00 (8:00 p.m). **Last car will be let in the Area in 18:00 (6:00 p.m.)**

## 2. Registration

Registration point is in the Entry Hall II. (see map) and it is active in the time of Assembly: **15. – 16.4. 2026**, 8:00 a.m.–6:00 p.m. . (Wednesday, Thursday).

**RECOMMENDATION:** With payment after the 3<sup>rd</sup> April 2026 it is recommended for Exhibitors to bring the Proof of Payment to the Registration point. **In case of unpaid Invoices, the Exhibitors won't be allowed to enter the Exhibition area. Registration of a company will be completed after a 100% paid.**

**The Exhibitor** will receive 5 Exhibitor's Identification cards for each registered company at the Registration. If the Exhibition Area is larger than 30 sq. m., the Exhibitor is eligible for one more Exhibitor Identification card for every 10 sq. m. started. Exhibitor's Identification card will allow one entry every day of the Fair, if a need arises for the Holder to leave the Fair Area, a return pass will be provided, which will work concurrently to an Exhibitor's Identification card.

The Exhibitor's Pass is **non-transferable**.

**More Exhibitor's Identification cards are available for purchase at the price of 350 CZK / pc at the Registration Point.**

Registration Point will also hand out pre-ordered parking cards for personal cars of the Exhibitors. Exhibitors will also receive 1 Catalogue of the Fair, plus any other informational materials. In case of further need, Catalogues can be purchased at the Cashiers desk at the Entrance to the Fair Grounds.

An **Assembly company** can pick their Assembly/Disassembly Identification cards at the registration point. The Identification card allow the Assembly crew to enter during the Assembly / Disassembly, but they do NOT allow an entry during the Fair. Assembly parking passes will also be given out to the Assembly crew. The Assembly Crew is required to contact the Hallmaster of the Hall they will be building the stand in.

**Hallmasters** (marked organizers responsible for organization in the Hall) will be present in the separate Halls. It is necessary to always report the beginning and the end of

assembly process to them. They can also be turned to for help with issues during the Assembly.

### **3. Assembly**

Presence on the exhibition ground is permitted from the moment of registration of the exhibitor, based on the assembly and disassembly identification cards at the time specified in section 1.

**WARNING: All residual material and packaging have to be removed from the Exhibition Halls by 6:00 p.m. at the 16<sup>th</sup> of April 2026 (Thursday) and to clear the traffic routes for general cleaning and carpet placements.** In case it will not be cleaned, ABF, a.s. company reserves the right to remove the items with full reimbursement toward the Exhibitor.

**CAR ENTRY TO THE FAIR GROUNDS:** During the Assembly days 15<sup>th</sup> – 16<sup>th</sup> of April (Wednesday-Thursday), the car entry is available only with a filled out Assembly Parking Card. This card will be received upon Registration in Entry Hall II. **On the 16<sup>th</sup> of April (Thursday) the Entry will be valid with a proper Assembly Parking Card and a refundable deposit (50 EUR / 3 hours).**

**REFUNDABLE DEPOSIT:** On the 16<sup>th</sup> April 2026 (Thursday) a refundable deposit of 50 EUR (VAT included) will be collected at the entrance and refunded at the exit unless the allowed time of stay (3 hours) is exceeded, unless said otherwise. In case of exceeding the allotted time, the deposit will NOT be refunded and the PVA EXPO Grounds will issue a proof of sanction fee upon request.

We urge for respect of one-way traffic and other traffic signs at the Expo Grounds and the instructions of traffic and security services of the Grounds. Vehicles that would cause a stop of the traffic flow and whose drivers will not comply with the instructions of the traffic and security service will be towed at their own expense.

#### **PARKING during Assembly (15<sup>th</sup> – 16<sup>th</sup> April 2026)**

On the 15<sup>th</sup> of October, Parking at the Expo Grounds is available (entry after the Registration of a company and based on the Assembly passes and the Assembly Parking Card) in the allotted time specified in Section 1.

On the 16<sup>th</sup> of October, Parking is limited by the Refundable Deposit time.

#### **PARKING during the Fair (17<sup>th</sup> – 19<sup>th</sup> April 2026)**

If the Exhibitor did NOT order a Parking Card allowing them to park at the Expo Grounds, the parking will be limited by the Refundable Deposit time. In other cases, Parking will be available at the Visitor's Parking lot.

Overnight Parking is allowed after buying a daily Parking Card. Price for an overnight parking is 16 EUR/night for a car up to 3,5 tons.

**Stands provided through ABF, a.s. according to orders will be ready on Thursday 16<sup>th</sup> April 2026. Stands will be ready after 12:00. Stand supplies and preparing are available until 6:00 p.m. on the 16<sup>th</sup> April 2026.**

For supply deliveries in the duration of the Fairs a Refundable Deposit of 1 000 CZK is required for vehicles up to the size of a microbus.

The vehicles must leave the premises at least 15 minutes before the start of the Fair. Apart from allotted time, deliveries are forbidden.

Ordered Parking Cards allow entering and exiting the Exhibition Grounds as will only during the duration of the Fair.

Side doors of the Halls close ) at 6:15 p.m., only the frontal doors are used for Exit afterwards.

PARKING during the Fair: Parking inside the Expo Grounds is allowed on the allotted spots only with a valid Parking Card. Parking Card is valid for all of the days of the Fair and can be non-transferable (49 EUR including VAT) or transferable (57 EUR including VAT). Without a Parking Card, parking is allowed in the Visitor's Parking lot (200 CZK / Day). **OVERNIGHT PARKING INSIDE THE EXPO GROUNDS IS AVAILABLE ONLY WITH A VALID PARKING CARD (see Catalogue of Services). PARKING BETWEEN THE HALLS IS FORBIDDEN.**

EXHIBITOR'S ENTRY: Please note the control of Exhibitor's Identification card at the entrances in the duration of the Fair.

#### 5. Disassembly

Stand disassembly is allowed after the end of the Fair **19<sup>th</sup> April 2026 from 4:00 p.m.** and will continue **NONSTOP until 10:00 a.m. of 20<sup>th</sup> April 2026** (Sunday – Monday).

STANDS PROVIDED THROUGH ABF, A.S.: **Clearing out the stand HAS to begin immediately after the end of the Fair on Sunday (19. 4.) and ended the same day at**

**10:00 p.m.** After this a disassembly of all stands (including those not cleared out) will begin and the ABF nor the realization company takes any responsibility for any losses or damages.

VEHICLE ENTRY: We urge the Exhibitors to enter to the Expo Grounds only to load an already disassembled stands ready to transport and to heed the instructions of traffic and security service.

In case of any garbage or damage of the Exhibition area or the rented furnishings will be given to the Exhibitor for a full price. In case of damaged OCTANORM panels, Exhibitor will be charged 900 CZK per every damaged panel based on the photographic evidence. Exhibitor does not have the right to keep the damaged panels.

## **6. Technical and operating conditions**

ORDERING ADDITIONAL SERVICES: Any and all changes regarding the orders of technical services, building or equipment required by the Exhibitor after the beginning of the Assembly will take place AFTER completion of regularly ordered works and services of other Exhibitors. This additional order can be charge to up an additional 100% of a standard fee. The fee will be paid on the spot in cash.

## **7. Security and insurance**

During the assembly, the Fair and the disassembly the organizer is ensuring basic security of the Expo Grounds. The Security is authorized for random checks of any and all vehicles entering or leaving the Expo Grounds as well as the identification of the people entering the area. With a concurrence with Business Terms and Conditions of ABF, a.s.

for Participation of Exhibitors in the Trade Fair, the organizer does not take responsibility for loss, destruction or any damage to the exhibit(s), the equipment and the furnishing of the stands, the goods or packaging regardless if the loss, destruction or damage will occur during the Assembly, transport or in the duration of the Fair.

Insurance can be arranged before the Fair or at the Expo Grounds (more information at the Registration Point in the Entrance Hall II.). The organizer of the insurance is the insuring company **Total Brokers, a.s.**, whose representative can be found at the Entrance Hall II. the first day of the Fair:


